Didactic Description

The Advanced Origin and Cause Seminar is designed to enhance the knowledge and skill levels of participants responsible for conducting criminal investigations related to origin and cause.

The curriculum involves emphases on scientific knowledge and investigative skills required to identify fire causation as it applies and utilization of the scientific method in determining origin and cause.

Presentation involves the in-depth study of fire dynamics, fire chemistry, burn pattern analysis, identified fuel package, ignition source and effects of ventilation, litigation the prosecutor and the defense attorney, evidence collection and testing requirements for evidentiary exhibits, detailed understanding of the insurance policy, insurance company special investigation unit and insurance fraud.

Instruction will be presented through classroom lectures, audio visual, handout materials and practical exercises. A written test will be administered at the completion of the course; certificates of successful completion will be issue at the end of the seminar.
